About WIA Employment & Training Project

WIA is a federal employment & training legislation that is intended to increase the employment, retention and earnings of participants, which will improve the quality of the workforce, reduce dependency and enhance the productivity and competitiveness in the quality of life for individuals.

Five Sandoval Indian Pueblos, Inc. (FSIP), Employment & training Project administers two programs: Adult programs and Year-round Supplemental Youth Services.

#### Who is Eligible....

To be eligible for Intensive Services one must be a tribal enrolled member from one of the following Pueblos: Pueblo De Cochiti, Pueblo of Jemez, Pueblo of Sandia, Pueblo of Santa Ana, Pueblo of Zia and the Pueblo of San Felipe.

Other Eligibility Criteria: Meet the Federal Income guidelines published through DOL/ETA/DINAP federal register.

# **Adult Program**

This program is designed to service individuals 21 and older. Individuals may be places in employment or be provided funds to advance their education. There are three (3) adult program components and support services.

**Classroom Training (CRT)** - enrolls adults in short term training institutions. Participants are allocated funds to pay for books, supplies, uniforms, or fee/tuition.

On The Job Training (OJT) - Individuals considered to semi -skilled and are familiar with the general concepts and requirements of the work place will be enrolled in an OJT activity. Actual length of training will be determined at the time of enrollment and funding available.

Work Experience (WE) - Provides temporary work activities to individual who lack general concepts of a work

place and are provided experience and knowledge through hands-on job training. Length of training is up to 10 weeks,/ dependant upon funds availability.

## **Year-Round Youth Services**

**Books/Supplies** 

This program is designed for youths between the ages of 17 to 21, who are enrolled full time students, and who fall into one or more of the following criteria: -At risk/dropping out of school -Individual w/Disability -Basic skill deficient -Failing Grades -Education attainment is one -Potential Drop Out or more grades below normal -Offender -High Absenteeism Rate -Youth Referred thru Tribal Courts -Pregnant or Parenting Youth Participants are eligible for Classroom Training services

or Work Experience depending upon funding available.

## **Supplemental Summer Youth Services**

This program was deigned to provide temporary work experience during the summer months to economically disadvantage and at-risk Native American Youth who meet the Federal Low Income criteria.



Placements are made at the tribal communities, non-profit organizations and employers within the public/private sector of Bernalillo, Albuquerque, Santa Fe, Jemez Springs. Participants are compensated at an allowable rate of pay, no less the federal minimum wage with fringe benefits.
